

A Letter from the Retiree Club President

For some time now, the Directors and Officers of the Retiree Club have been discussing how we could modify the name of the Club to make it more in sync with the Northrop Grumman name, without losing our Grumman heritage.

Last year, we decided to start by changing the masthead on the monthly Newsletters. Of the four options presented to the Board of Directors, they unanimously chose to use the name: "The Grumman - Northrop Grumman Retiree Club". We started using that wording in the November 2013, Newsletter.

One of the reasons for wanting to make this change is obvious: The number of club members is decreasing as the years go by. There are many Grumman heritage people who have worked for Northrop Grumman for the past twenty years and are now retiring. While we welcome anyone who worked for Grumman or for Northrop Grumman to join, the general feeling is that the "Grumman-Northrop Grumman" name might be more of a draw for those who have worked for both companies.

Bethpage Chapter Meeting

April 23, 2014

The Club's first luncheon at Crest Hollow this year brought out an enthusiastic group of retirees on a nice, breezy spring day. At Noon, the Crest Hollow began serving their typical delicious meal. After coffee and dessert, the meeting was started with 2nd VP Pat Sullivan leading the Pledge of Allegiance. President Betty Bohlander asked for a moment of silence for our military heroes and loved ones.

The members were asked for corrections or additions to the March minutes as published in our Newsletter. There being none, the minutes were accepted as printed.

Betty introduced guest speaker Janine Valentiner, Regional Director of Business Development for Bristal Assisted Living. Janine was accompanied by Rachael Koutrouby, Bristal's Community Liaison. Janine oversees development of strategic corporate and professional relationships, the non-profit marketing initiative, and the community outreach initiative. She is a frequent speaker at events for senior groups where she educates on topics that impact the lives of seniors. She is acting co-chair of the Senior Umbrella Network (SUN) in Nassau, a member of SUN in Suffolk, the vice president of Gerontology Professionals of New York (GPNY), and the vice chair of the newly formed Long Island Family Caregivers Coalition.

Janine started her talk by introducing a recent book called the "Blue Zones", which describes a National Geographic expedition around the world to Blue Zones: areas in which people reach age 100 at ten times the average rate of the rest of the world. The book identifies the top five places; one of these is Loma Linda, California, an Adventist community, where residents outlive the average American by a decade. "Blue Zones" identifies the nine factors that these places have in common and calls them "The Power of Nine." The nine factors are:

 Move naturally by walking and other normal daily chores, not necessarily with heavy exercise.
 Have a purpose in life.



3. Downshift from stress through meditation and prayer.

4. Observe the 80% eating rule: you eat until you are 80% full and stop.

5. Eat lots of veggies - meat perhaps five times a month.

6. A glass of wine at 5 PM.

7. Develop a need to belong by attending faith-based services.

8. Hold family first (at Bristal, staff is family).

9. Develop meaningful associations with people you surround yourself with.

Janine extolled the merits of Bristal Assisted Living and described in detail how they try to adhere to the Power of Nine to enable all who reside there to enjoy and flourish in the experience. The most modern of technologies is utilized. Janine described a joint program the Bristal has with Hofstra University, in which seniors at the Bristal use a computer to SKYPE (a direct video link) real time with lecturers at the university and can have a direct Q&A capability with the professors. She laughingly, described one session where the seniors met with college students and discussed the similarities and differences between the sexuality on post WWII college campuses with that found on today's college campuses. Bottom line-maybe toga parties, Spring break in Cancun, and vodka consumption are new but the rest of the "good stuff" is same ole-same ole. Guess time hasn't changed Mother Nature. Aren't scientific studies wonderful?

Bristal also has residents who have serious health issues. Here, as an example of modern techniques, Janine described how Equine therapy (interaction with horses) is used for some Dementia patients to help exercise the memory process. She has received positive feedback from the families of the sufferers, telling her that their Moms and/or Dads remember and talk about the horses that they have spent time with during the week, whereas they can't remember what they had to eat five minutes before.

At the end of her talk Janine noted that Grumman -Northrop Grumman retirees are immediately greeted with a \$1000 bonus upon joining the Bristal. Both Janine and Rachael were presented with gifts from the club with our thanks for a nice presentation.

• Betty Bohlander spoke about the Club's efforts to address the need for a new identity, to bring the Club more into sync with the Northrop Grumman name without losing our Grumman heritage. [Editor's Note: Betty's comments are presented in her letter to Club members, on Page One of this Newsletter.]

• First VP Bob Ripp spoke about the new Retiree Medical Plan mailing and subsequent informational meetings held during the week of April 20, at locations on LI. A show of hands indicated that almost all attended the meetings but a few people said that they had not even received the initial informational mailing. They were given the OneExchange phone number and told to contact them immediately. Bob stressed that everyone should go on-line or call OneExchange to provide them with a personal profile (Doctor's names and medications taken) and to set up an appointment for the final enrollment procedure. Bob noted that when registering for the insurance option of choice, husband and wife must register separately. After August 1, 2014, no more deductions for health insurance or prescription plans will be taken from your pension check. It will be your responsibility to pay for the insurance plan(s) that you choose. Bob also stated:

"<u>Do Not Call The Retiree Office in Regard to the</u> <u>new Health Insurance Situation</u>. <u>We Cannot Help</u> <u>You</u>. <u>Call One Exchange.</u>"

April 23, 2014

Club President Bob Prais called our meeting to order promptly at Noon and lead our 66 members and guests in the Pledge of Allegiance. Following a meaningful prayer, Sergeant-at-Arms Ed Romano announced the passing of our long time friend and club member Gene Sirota. Gene served as club president in 1991-92 and was active in promoting club activities until poor health necessitated moving back up North this past year.

The Suntree Country Club highlighted their seafood delight in our luncheon buffet, starting with hearty seafood chowder, followed with a cold seafood salad, and a hot shrimp and fish combo in creamy lobster sauce—beef was also available.

VP John Lau introduced our distinguished speaker,

retired USAF Major Joseph H. Reus Major Reus told us of his experiences in WWII, starting with ditching into the English Channel after his first mission over Germany, in 1943. Later, back in action, on his second mission he parachuted from a burning B-24, was taken prisoner by the Germans, and taken to Stalag 1 on the Balkan coast. In general, during John's 16-month confinement, he was treated guite well, with sports and entertainment. The prisoners were even allowed to collect mussels to supplement their meager diet. As the war drew to a close, the German guards left to surrender to the British and avoid being captured by the Russians. The Allied officers were held for some time by the Russians, until pressure from Washington succeeded in getting them released for transport back to England.

Side issue: When asked about the 16 RAF escapees, executed by the Germans (as shown in the movie, "The Great Escape,") John said they were told in England that - per Churchill's orders - all Nazis involved had been tracked down and executed. In contrast, some of the German fighter pilots have become good friends of our veterans.

John's subsequent 20-year career in the USAF included missions in North Korea and time in B-47s and B-52s. Back in Florida, he worked for ten years with our Grumman Gremlin Restoration Team.

<u>Nostalgia</u>

In the March 2013 "Grumman History", there was a report of the rescue of five fishermen in rough seas. This brought to mind a similar flight right here in our own neighborhood: this flight was from Grumman's Bethpage airport.

I worked as lead-man of the Plant 4 Radar Shop. Our job was to bench test, install, ground test, and flight test radars for both production airplanes and "IRAN" airplanes. "IRAN" was short for an Air Force contract to "Inspect and Repair or Replace As Necessary" on the SA16 Albatross.

All of us in the Radar Room enjoyed the flight test part of our work on both the production aircraft (the S2F) and the IRAN Albatross. We set up a list of names; when your name got to the top, you were next to fly.

One day, Operations told the Radar Shop an SA16 was ready for flight test. My name was at the top of the list, so I went to Ops to join the crew.

The Plane Captain was to fly as co-pilot. The two mechanics lifted the floorboard and crawled down into the bilges to check for leaks when we landed on water. In addition, we had a radioman, an electrician, and me: the radar man.

The pilot, Joe Gaeter, announced that this was to be a routine IRAN flight test, and we would do the leak test on Candlewood Lake, in Connecticut.

As we walked across the Plant 4 apron, our tower called us on the P.A. system, and said: "Republic just said they have lost an airplane in Long Island Sound, and does Grumman have an amphib available to help look for he pilot?"

Our routine test flight suddenly became a Search & Rescue mission. We did a quick but safe pre-flight check and took off. As we turned North, the republic tower told us the pilot reported he was OK, in his one-man inflatable raft, paddling to a large rock in LI Sound. I saw a non-moving radar target in the middle of the Sound, and told the pilot. We decided that would be a good place to begin our search.

I gave pilot Joe range and bearing to the rock and he turned the airplane toward the target. At the same time, the co-pilot reported a movement on the rock. As we came closer, the co-pilot's reported: "It's a man, and he's waving at us."

Joe made a turn around the rock to check for boats, floating debris, or other rocks that would prevent us from landing. With no obstacles sighted, Joe landed the airplane.

Between Joe maneuvering the SA16 and the downed pilot paddling, we were soon next to the raft and pilot. When he was near our open door, we grabbed him and hauled him aboard. As soon as we told Joe that we had the pilot, he said, "Ready for take off; we're heading for Republic." Both towers were updated as the rescue progressed.

I asked the pilot what happened? He said: "When the tail came around to meet the nose, I decided it was time to eject." I knew there was little chance of getting a straight answer.

When we arrived at Republic, there was a huge crowd to greet the wet-but-well pilot. There was a lot of hand shaking and backslapping. When the celebration quieted down, we got back into the Albatross and returned to Bethpage. Our "routine test flight" was over.

[For readers not familiar with the Long Island aviation environment of that time: Grumman's operations and airport were in Bethpage; Republic Aviation Corporation designed and built Air Force airplanes in Farmingdale, where they had their own airport. The two communities are about ten miles apart.]

Grumman History - Chapter 22

COST OVER PERFORMANCE (1971)

The Tomcat crashed in the waning days of 1970. Undaunted, Grumman Aerospace's President Lew Evans said, "We've got a great airplane here. Although we've had a setback today, as far as I'm concerned, nothing will slow the program." Lew was correct. The fault, quickly found, was the result of [unintentionally] perfectly tuned vibrations, caused when one engine was throttled back to idle. These vibrations caused the titanium hydraulic lines to fail, leading to loss of control system hydraulic fluid and then total loss of aircraft control. The shock of the crash was quickly ameliorated when investigation showed that the remedy principally involved changing the hydraulic line clamps. Flight-testing resumed in May.

Grumman's other projects were doing well. In January, the EA-6B Prowler was introduced into Whidbey Island and fleet service; the 488th and final A-6A was delivered; and the third generation E-2C Hawkeye, now capable of detecting targets over land and water, had its first flight.

LM-8, carried aboard Apollo 14, became the third lunar lander on Feb. 5, when it landed within 100 feet of the chosen spot. Astronauts Shepard and Mitchell explored the area for a record-setting nine-plus hours. At the end of the second and final surface excursion, Shepard wanted to demonstrate his golf prowess to the global TV audience. Hampered by the stiff space suit, it took three one-armed swings to successfully stroke the ball. "Miles and miles and miles!" exclaimed Shepard as the ball sailed into the starry-blackness of the lunar sky, thereby becoming the longest drive in golf history.

Turmoil over Vietnam pervaded the headlines, as did stories of defense program cost overruns and Apollo mission costs. While these negative events were happening, Lew Evans was named CEO and Chairman of the Board of Grumman Aerospace, as Clint Towl became Chairman of the Board of Grumman Corp. "Doc" Tripp, LM Vice President, was compelled to write an article about the benefits of the manned space program and then Lew Evans penned an article about difficulties Grumman faced. Evans cited the public's anti-military/anti-technology sentiment while also faulting the aerospace industry's sloppy management.

William Proxmire, senator from Wisconsin and nightmare to the military establishment, had gained notoriety by awarding "Golden Fleece" awards to government programs he deemed as most wasteful. At his press conference in April, he cited both the F-14 and McDonnell's F-15 as expensive, too complex, too sophisticated, and not needed (he targeted other defense projects as well). Political and public pressure forced the Navy, a firm supporter of the F-14, to perform study after study to find a lower cost approach. One study involved modifying the F-15 for carrier operations, an idea pushed by Senator Symington from Missouri, the state where the F-15 was being built. Proxmire pushed for a "lightweight" fighter. All these studies continued to show the superiority of the Tomcat.

In the midst of this maelstrom, Grumman announced that the cost of the F-14 was to increase significantly due to both inflation and the general business downturn. Grumman's workforce had declined from 37,000 in 1968 to 24,000 as the Reduction in Force (RIF) ended the Fall of 1971. The resulting significant impact to overhead costs had not been properly considered when Grumman signed the F-14 contract.

Fighting against the negative tide of public pressure, Hawaii's Senator Inouye defended Grumman and the aerospace industry. He cited the Foxbat (Russia's latest fighter), the loss of over 370,000 skilled aerospace workers during the previous two years, the disaster of "total package procurement" contracting, and inflation that had increased from a three year average of 3%/year to over 5.5%. The battle of F-14 costs would continue to escalate for some time.

While the F-14 was Grumman's largest program, the wide spectrum of Grumman's activities continued unabated. Its "bread and butter programs" were doing well as the KA-6D, the tanker version of the Intruder, was acclaimed in the Navy press, and the E-2C went into production. Grumman Ecosystems became a separate subsidiary, with Bill Zarkowsky as President. Ecosystems' Gulfstream 1, outfitted with a sensor suite comprised of magnetic, infrared, and photographic detectors, prepared to take on its first major job, the geophysical survey of northern Greenland. Sales of Grumman's bi-plane Ag-Cat crop duster hit 877; the Department of Transportation awarded Grumman \$3.5 million to build a 300 mph train, the Tracked Air Cushion Research Vehicle (TACRV); and the Flagstaff hydrofoil boat, outfitted with a 152mm gun, hit its target three out of four times while traveling at 40 knots, providing Grumman bona fides in its quest to win the Navy's PHM hydrofoil gunboat program.

When the modified LM-10 lifted off in July, it carried life support allowing for greatly extended lunar stays and a lunar rover greatly expanding exploration capability. Astronauts Scott and Irwin compiled a record 18 ½ hours and 17 ½ miles traversed during three successful lunar surface excursions. Upon takeoff from the moon, the TV camera was positioned for the first time to transmit pictures of the LM ascent stage leaping off the descent stage as the ascent stage blasted off to rejoin the orbiting Command and Service Module.

The Space Shuttle study was extended for eight months. Notably, the Grumman/Boeing team achieved parity with Rockwell and McDonnell as NASA changed their preferred totally reusable vehicle approach to include the Grumman/Boeing external fuel tank configuration, as escalating costs pressed down on the Shuttle program. The competing industry teams were ready for the Request For Proposal (RFP), anticipated in mid-December. The future of the manned space business at Grumman depended on winning this program as the end of Project Apollo was clearly in sight.

Bad news came as Grumman was notified it had lost both the High Energy Astronomical Observatory (HEAO) and the PHM hydrofoil programs. Juxtaposed against those bad tidings was the good news that OAO-2 had – remarkably - achieved its third anniversary in space as 1971 ended.

Overall, 1971 was not a good year for Grumman, although it had faired better than most in the industry. While the F-14 had successfully completed the Navy's preliminary evaluation, Grumman continued to lose money on every aircraft. Grumman actually lost money in 1971 as sales dipped below \$800 million, down from \$1.2 billion in 1969.

As the Department of Defense and NASA continued to prioritize cost over performance, the nature of the aerospace business would be forever changed.
